RELEASE AND WAIVER OF LIABILITY

By signing this document, I am expressly verifying that I have the legal capacity and / or authority to bind myself, my child and any other parent and / or legal guardian of the participating child to this agreement. 2. I understand that the Jason Rader Football Camp is a physical activity that will be conducted outdoors. As such, I understand that summer temperatures and outdoor conditions will be occurring during the camp. Further, I expressly represent and warrant that my child is in sufficient physical condition to participate in this football camp and I do not expect or require Jason Rader, LLC or anyone involved therewith to conduct a physical examination to determine the child's level of fitness to participate in the football camp.

For myself, any other parent and / or legal guardian and child, I knowingly and freely assume any and all such risks, both known and unknown, even if arising from the negligence of those associated with the Jason Rader Football Camp / Jason Rader, LLC, and assume full responsibility for my child's participation in this football camp; and,

Myself, any other parent and / or legal guardian and participating child, and on behalf of my / our heirs, assigns, personal representatives and next of kin, hereby release the Jason Rader Football Camp / Jason Rader LLC, the other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and leasors of premises used to conduct the event ("Releasees"), with respect to any and all injury, disability,
